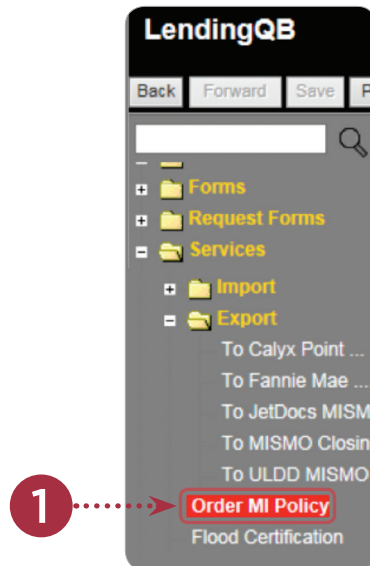


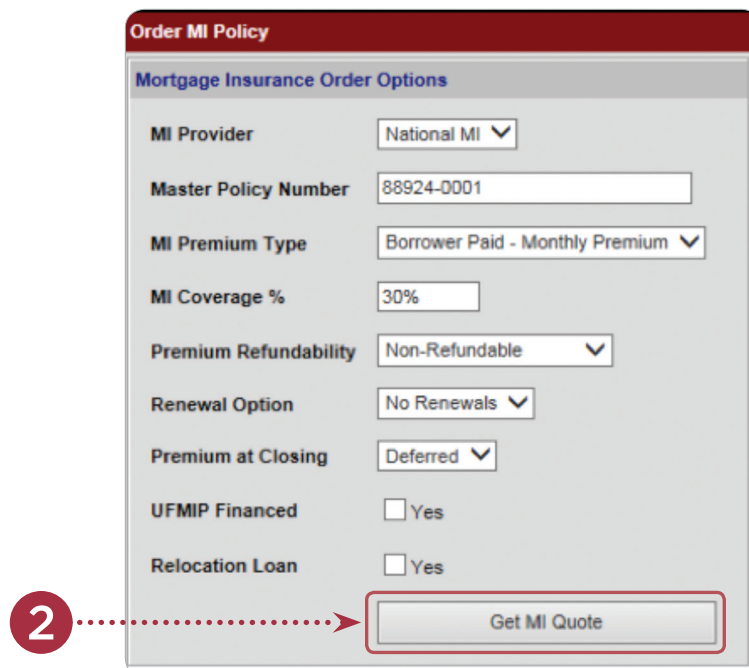

1. From within your loan in LendingQB, use the left side Navigation pane to select **Order MI Policy** in the Services/Export folder:



2. Complete your MI order details. Please note that LendingQB always requires that you request a rate quote before you can order MI. Select **Get MI Quote**.



3. The MI Quote opens in a separate window. Select **Apply Quote and Order Policy** to submit your application and please note the following:

A. **Delegated submission** – at the time of submission, if your loan meets National MI guidelines you will receive your MI commitment via Lending QB.

B. **Non-Delegated submission** – please contact your National MI Account Manager or National MI's Solution Center to discuss your document delivery options. We will notify you when your application has been approved or if we need additional information to underwrite your application.

C. The MI quote details and premium information are populated in the **Mortgage Insurance Policy Screen** and the **Upfront MIP/FF Screen**.
